(Regulation 2023/955 establishing a Social Climate Fund)
- Carbon Border Adjustment Mechanism Regulation of 2023 (Regulation 2023/956)
(Regulation 2023/956 establishing a carbon border adjustment mechanism)
- Car CO₂ emission Regulation (Regulation 2019/631)
(Regulation 2019/631 setting CO₂ emission performance standards for new passenger cars and for new light commercial vehicles)
- Net Zero Industry Act of 2024 (Regulation 2024/1735)
(Regulation 2024/1735 on establishing a framework of measures for strengthening Europe's net-zero technology manufacturing ecosystem)
- Renewable Energy Directive (RED) of 2018 (Directive 2018/2001)
(Directive 2018/2001 on the promotion of the use of energy from renewable sources)
- Regulation on Deforestation-free Products (EUDR) of 2023 (Regulation 2023/1115)
(Regulation 2023/1115 on the making available on the Union market and the export from the Union of certain commodities and products associated with deforestation and forest degradation)

(Regulation 2024/1991 on nature restoration)
